FRAMEWORK AGREEMENT

THE IMPLEMENTATION OF THE SECOND SWISS CONTRIBUTION TO SELECTED MEMBER STATES OF THE EUROPEAN UNION TO SUPPORT MEASURES IN THE AREA OF MIGRATION

1. General provisions

- 1.1. This Country-Specific Set-Up is an integral part of the Framework Agreement between the Swiss Federal Council (hereinafter referred to as "Switzerland") and the Government of the Hellenic Republic (hereinafter referred to as "Greece") on the implementation of the second Swiss Contribution to selected Member States of the EU to support measures in the area of migration (hereinafter referred to as the "Framework Agreement").
- 1.2. For the purposes of this Country-Specific Set-Up, the definitions in the Framework Agreement shall apply.
- 1.3. This Country-Specific Set-Up lays down the thematic allocations of the Contribution and the specific rules agreed between Switzerland and Greece, as well as the attribution of responsibilities and tasks to entities involved in the implementation of the Switzerland-Greece Cooperation Programme and in Support Measures respectively.
- 1.4 For specific rules and procedures not provided in the Country Specific Set-Up, the provisions of Regulations shall apply.

2. Roles and responsibilities for the Switzerland – Greece Cooperation Programme

2.1. National Coordination Unit

The Partner State has authorized the Secretary General for Migration Policy in the General Secretariat of Migration Policy of Ministry of Migration and Asylum to act on its behalf as National Coordination Unit of the Switzerland – Greece Cooperation Programme.

The role and responsibilities of the National Coordination Unit are set out in the Regulations.

2.2. Paying Authority

The Paying Authority is the General Directorate of Administrative and Financial Services of Ministry of Migration and Asylum. The roles and responsibilities of the Paying Authority are set out in the Regulations.

2.3 Audit Authority

The Audit Authority is the Verification Authority of the General Secretariat of Public Investments and ESPA of the Ministry of finance. According to 9.2 of Regulations the audit of both the financial regularity and the internal control system will be relied on statutory financial external audit reports in accordance with ISA. The Verification Authority of the General Secretariat of Public Investments and Espa of the Ministry of National Economy and Finance will be responsible for the verification of the findings and reports of the appointed external auditor.

Objectives	The objective of the support measure is to improve current regional asylum offices (RAO's), in order to increase the capacity in treating asylum cases. These include improving the overall standard of the offices, especially with a focus on the waiting rooms and hearing rooms in which asylum seekers are received.
Strategic Focus	The support measure would increase the capacity of the asylum offices to carry out their daily work. This would lead to more cases being handled at the RAO's and the procedures becoming more efficient. The impact for the final beneficiaries would be more comfortable and secure waiting and hearing areas and shorter waiting times for asylum decisions. It would also lead to a decrease in pending cases which would contribute to the overall amelioration of the asylum procedure in Greece. The above action is part of the National strategy for migration which aims to improve the Asylum Process and minimize the impact on the local communities by creating/improving infrastructures and reducing the burden on local communities by speeding up the Asylum procedures in accordance to the European regulations for migration.

Objectives	The Support Measure is intended to enhance the Asylum Process for the Asylum Seekers with vulnerability status by ensuring that the two Asylum Units will be able to operate at full capacity. The Measure will assist the vulnerable migrants but will also contribute on institutional and policy levels. RIS will also be supported.
Strategic Focus	The Asylum Service is the relevant Service for processing asylum and related requests and from 2013 onwards over 423.000 asylum applications have been submitted to the Service. Asylum Service operates 24 Regional offices and Asylum Units and has about 900 employees, 60% being fixed-term contract employees. During the 10 years of operation, Asylum Service has gained valuable experience in handling asylum applications (in many cases in harsh conditions) and dealing with asylum seekers with vulnerability status, In this context and in order to tackle the challenge of the increasing refugee flows — and the corresponding increase on the number of Asylum seekers with vulnerability status, to guarantee access to asylum process and provide a timely conclusion of the examination of asylum applications, the Greek Asylum Service needed to expand its capacity and decided the operation of two new Asylum Units, in Athens and in Thessaloniki, specialized on Asylum seekers with vulnerability status.

Objectives	The objective of the proposed project is to enhance the protection and mitigate risks of abuse, exploitation, and trafficking to the most vulnerable of UMC, those identified living homeless or in precarious accommodation conditions through support the operational aspect of National Emergency Response Mechanism's services. The operational support involves (a) the function of Info Desks and Mobile Units by multi-sectorial team of highly skilled and experienced staff with the purpose of tracing homeless UMC, assessing their vulnerability, providing child protection services and referring the children to the national accommodation system, (b) the provision of tele-interpretation services to the NERM's Tracing Line for effective communication with homeless UMC contacting the Line asking for

	accommodation, and (c) escorting services to unaccompanied migrant children in order to be placed to accommodation facilities throughout Greece.
Strategic Focus	The National Emergency Response Mechanism (NERM) seeks to serve as an appropriate immediate response mechanism for unaccompanied migrant children identified homeless or in precarious living conditions, factoring in both accommodation needs, and broader protection needs. It is coordinated by SGVP (former SSPUAM) and involves the participation of several key stakeholders, namely one UN agency (IOM) and three NGOs (ARSIS, Network for the Rights of the Child-NRC and METAdrasi), while closely cooperating with key national authorities (the Hellenic Police, the Greek Asylum Service, and RIS). NERM aims, among others, to identify unaccompanied migrants children, ensure a child rights-based and comprehensive response while address the emergency need for accommodation for children who are homeless by providing holistic support to children until their referral and placement to the care arrangement that is deemed suitable according to their gender, age, and best interests.

Objectives	The overall objective is to increase the integration of refugees in Greece. By doing so, the likelihood of irregular migration can be decreased. The participation in the events organized in the framework of the project can lead to creating a sense of being part of the local community.
Strategic Focus	The support measure will convey to a population of approximately 5.000 (2.000 unaccompanied minor and 3.000 asylum seekers in sites/cities) beneficiaries per year, focusing on the values and the general philosophy of Olympism, as a means to promote the principles of cultural diversity, peaceful coexistence and solidarity. The support measure contributes to the country strategy of successful integration as it is familiarizing asylum seekers with the culture and practices of host communities. By creating linkages and inter-cultural exchanges between the host and hosted communities, the project seeks to promote the cooperation of the communities, create the sense of being part of the same community through interconnected lives, and eventually jointly design and implement joint events, that will demonstrate the potential and benefits of migrants' integration. Activities will be designed through a participatory approach and will include: trainings and awarenessraising events around cultural orientation (basic notions concerning the European and Greek culture, history, tradition, contemporary customs etc.), life skills (e.g. communication skills, practical daily

	matters, financial literacy etc.), knowledge on practical aspects of European citizens' life (e.g. living and working in the EU), and on the shared European values (e.g. freedom, equality, justice) which draw from the spirit of Olympism. Other sensitization events and nation-wide media campaigns will also be organized to sensitize the local key stakeholders and further promote this initiative.

Objectives	Within the educational process, Odyssea creates a cultural hub that welcomes diverse mentalities and serves as an integrational stepping stone for vulnerable individuals to escape a state of dependency and achieve self-reliance. Each beneficiary receives the specific training that best responds to their specific needs and priorities identified during their initial introduction to the project. Training courses will include: Soft, digital and professional skills training, Empowerment against human trafficking and illegal migration, Vocational training and apprenticeships Moreover, the project will provide disadvantaged migrants with a means to achieve agency and social integration by actively engaging in their community's issues and discovering suitable career paths for themselves and bridge the industry representatives with talented job seekers in order to mitigate their barriers in workforce development while at the same time improving their social impact and the working conditions of vulnerable groups through DE&I training.
Strategic Focus	Odyssea has a strong track record of vocational training developed and provided in the fields of construction and the blue economy. Replying to the needs in the Shipbuilding and Repair Zone of Perama, Odyssea will develop and provide vocational training related to the professions of the zone. To ensure the quality of the training, Odyssea will collaborate with the UNION SHIPBUILDING - SHIPREPAIRING OF GREECE (SENAVI). SENAVI was founded with the mandate to address the problems of the NEZ Perama and achieve the best possible representation of all specialties and professionals, the entrepreneurs of NEZ Perama. With the support of SENAVI, Odyssea will develop tailor-made training for specialities of the zone including: - Sanders - Sheet metal workers - Applicators - Electricians - Electronics technicians - Electric welders - Cleaners - Construction of scaffolding workers - Boilermakers - Manoeuvre workers - Mechanics - Insulator workers - Shipbuilders - Ships' carpenters - Pipe fitters - Flame operators - Lifting and transport equipment operators - Painters. Another focus area will be the training and qualification of truck drivers. Following the great need in the labour market for this profession, Odyssea will collaborate with specialized professionals to train truck drivers. The outcome of the training course will be a professional licence of category C which

	translates to trucks up to 7500 kg gross weight, capable of towing a trailer up to 750 kg.

Objectives	This proposal aims to help refugees and migrants, who are legally in the country, to know the Greek and the European way of life. In particular, it aims to facilitate their social integration through a basic but also global acquaintance with the religion, culture and social reality of Greece and Europe. The strategic focus and relevance of the Support Measure is to make refugees and migrants to understand that the European way of life is a response to religious fundamentalism and radicalization, and premise for a
	peaceful and prosperous social coexistence. A six-month pilot academic program will take place for TCNs in the premises of the University. Outreach and translations will be held by UN agency or an NGO.
Strategic Focus	It is evident that religion has re-emerged in Western societies in a dynamic way in recent decades, claiming a central role in the public sphere. The creation of a more complex mosaic of religions in the modern European public space, is due between others to the successive migratory flows that mark the 21st century. This new map of religions intertwined with political, social and economic institutions, contributes to the formation of the modern multicultural society and at the same time it is linked to social tensions and phenomena of violence. All these make imperative the need for an interdisciplinary and in-depth approach of the role of religion in modern times society. Moreover, it is necessary to acquire a broader acquaintance with the religious phenomenon (religious literacy) and education about religion (teaching about religion). A network of experts in Balkan countries regarding the fake news in Religion will be created and two big conferences on this matter will be conducted. Moreover, an observatory regarding religious fake news in social media will be created.

Objectives	In the core of the urban tissue of the Attica region and especially in the centre of Athens, the requests for psychosocial assistance of dozens of women (refugees) are accumulated on a weekly basis - women who are in precarious conditions and/or are homeless and face an even greater risk of exploitation, abuse and marginalization, due to their multiple vulnerabilities. Asylum seekers, refugee and newly arrived migrant women (in the pre-registration phase) face a multitude of vulnerabilities due to their gender, extreme health conditions, the very often fact of single parenthood and their refugee status.
Strategic Focus	The operation of the Open Accommodation Centre "A Step Forward" is continuous and uninterrupted (24 hours a day, 7 days per week) in order to provide quality reception conditions and support services in a comprehensive manner and on a daily basis. The capacity of the structure amounts to 44 unique beneficiaries at once. The building of MdM-Greece's Open Accommodation Center is located in the center of Athens and nearby to public schools and municipal social services, while the hidden location (for the protection of the beneficiaries) ensures the best possible service for the beneficiaries in terms of access to the necessary public and administrative services. PROVIDED SERVICES: 1. Provision of accommodation, food and basic necessities. Beneficiaries are placed in rooms of 4 or 2 persons. Specific essentials and hygiene items are provided on admission and they are entitled to a monthly supply of these items. Within the Open Accommodation Centre, four (4) meals per day are provided and clothing and footwear are provided, following an assessment of the beneficiaries' request. 2. Provision of psychosocial support services with social workers and a psychologist, including a) individual sessions, b) social history intake, c) assessment and design of a personalized support plan, d) social counselling, including information in the context of social orientation and integration, e) psychological assistance and psychoeducation, g) management of internal and external referrals, h) provision of material assistance (medical supplies and essentials), i) provision of support letters, j) follow-up and case closure - completion of cooperation whenever necessary. 3. Provision of legal support: a lawyer conducts sessions with the beneficiaries regarding their asylum application process as well as other issues related to their special vulnerability (e.g. several forms of GBV)

	4. Personal empowerment through group thematic meetings with the social workers and the psychologist of the program. The scientific staff plans and implements activities inside and outside the structure (visits to exhibitions, participation in external activities and festivals, wellness sessions, counseling and health promotion). 5. Provision of Health support is covered with ongoing and effective synergies with other MdM-Greece projects (Open Polyclinic in Athens), according to the beneficiaries' health needs.

4. Partner State specific rules and procedures
