



Required Documents for Schengen Visa C: Cultural and Sports (maximum 90 day's)

Gainful activity of more than 8 days per calendar year is subject to authorization by the competent office for migration, even if only temporarily and less than 90 days. The employer must take the necessary steps in Switzerland and apply for the work permit of the visa applicant at the competent office for migration.
